Through the support of the National Governors Association, the Governor's Office of Early Childhood is pleased to announce the **2016 School Readiness Summit**. The purpose of Kentucky's School Readiness Summit is to help school districts, early learning providers and community organizations throughout the Commonwealth make the vital connections and collaborations necessary for school readiness. **Preparing children for school is a community issue.**

We are calling on Superintendents/Assistant Superintendents to lead a School Readiness Summit team.

Participation in the 2016 Summit is limited to 25 teams across the state. Teams will be made of 5-8 members including the Superintendent/Assistant Superintendent. **Teams who participated in the 2015 School Readiness Summit are not permitted to participate for a second year. Teams who were previously denied can reapply.** Participating teams will be selected through an application process. Selected teams will participate in this 1-day event focusing on three areas:

- Helping Superintendents understand that collective action with community partners and parents is the key to preparing more children for school entry
- Providing the tools and knowledge to allow schools to engage partners and the public in preparing children in the early years
- Improving coordination between early childhood education and community partners

Most expenses will be covered for participating teams using National Governor's Association (NGA) grant funds. Included will be lunch and all materials needed for the day. **(Overnight lodging and mileage will not be included.)**

Teams chosen to attend the Summit may qualify for the following opportunities:

- **To receive technical assistance for certain projects developed through the Summit.**
- **To receive incentive opportunities for certain projects developed through the Summit.**
- **To obtain EILA credit for the 1-day Summit event.**
- **To obtain ECE-TRIS credit for the 1-day Summit event.**

To be considered for participation in this event, teams must agree to the following:

- **Attend the entire 1-day event.**
- **Create a 5-8 person team.**
- **The following person MUST be a member of the team and attend the Summit:**
 - **Superintendent or Assistant Superintendent**
- **Strongly preferred members of the team include:**
 - **Head Start Director or Representative**
 - **Child Care Director or Representative**
 - **CECC Chair or Representative**
 - **School District Staff Member**

 - **Follow-up on 30, 60, 90 Day Action Plans via video conference/conference call in March 2017**
 - **Submit a Ready Kids Conference presentation which includes outcomes from Summit Action Plans by May 15, 2017. Three to five presentations will be selected to be presented at the Ready Kids Conference on June 29, 2017, at the Galt House in Louisville, Kentucky. If selected, your team agrees to participate in the session.**

The deadline to submit applications is **August 29, 2016**.

- **Strongly Preferred Team Members Apply (25%)**
- **Response to Question 6 (50%)**
